## **REACH-regulation (EG) Nr. 1907/2006 from 21.04.2013**

(Supplement (EC) No 2020/171 of 23.02.2020)

### **SVHC-substances**

(Extension of the candidate list from 25.06.2020 – REACH 209)

**Latest updated status: 2020-07-10**

According to the provisions of REACH Suco as manufacturer of products, is to be regarded as a 'downstream user'. As a matter of principle Suco as downstream user, observes all requirements resulting from REACH.

Products, which you purchase from us, are, by definition of REACH, not to be registered. Chemical substances contained in our products, which may possibly be subject to registration, have to be registered exclusively by our pre-suppliers.

In your own interest and in ensuring a high level of product safety, we follow the implementation of REACH and the resulting demands intensive.

Suppliers are obliged to notify the customers if their delivered products contain more than the mass percentage of 0,1 of substances of Very HIGH Concern (SVHC) after Article 33 and 57 a-c Registration with ECHA will then be necessary. Up to now we have not received any announcement from our suppliers that their products are over this limit. Because we do not process such substances on our own, we currently act on the assumption that the above mentioned limit is not exceeded in our products.

Additional, following the declarations of our suppliers, our products do not contain radioactive material, are asbestos-free, non-carcinogenic (category 1a and 1b), mutagenic (category 1a and 1b), or toxic for reproduction (category 1a and 1b) and do not contain ozone-degrading substances. (ODS)

Under to Article 31 - EC 1907/2006 we are not a producer of hazardous materials  
(Creation of Safety Data Sheets - MSDS or SDS)

## **GHS / CLP-regulation (EG) Nr. 1272/2008 from 10.03.2011**

We are not concerned to the GHS / CLP - Regulation EC 1272/2008.

(Regulation on new labelling and packaging of substances and mixtures)

## **Packaging law (VerpackG) from 01.01.2020**

Our products are delivered exclusively to companies and typically not to private end users. The limit filling size per package is < 22 kg. Therefore, neither the folding boxes nor the inner bags are subject to system participation. According to § 7.5.2 of the Packaging Act, our transport packaging also does not fall under the system participation obligation.

Our products are not listed at the central packaging register "LUCID".

If a commercial end customer wishes the packaging to be taken back, we will take it back free of charge and dispose of it via our disposal companies SITA or REMONDIS within the framework of the Green Dot.

We are constantly observing the development of the regulations and instructions in this matter and would inform our customer in case of changes.
